Quarterly Animal Welfare Incidents Report

Food Standards Scotland (FSS) is responsible as the competent authority under both EU and Domestic legislation, for ensuring compliance with all applicable Animal Welfare laws. Our Official Veterinary staff carry out daily monitoring in abattoirs to ensure not only that food business operators are acting responsibly and legally to maintain high standards of animal welfare, but also to report any non-compliances out with their enforcement area to the relevant bodies.

Animal welfare issues which are considered to have originated on farm are reported to the Animal and Plant Health Agency (APHA). Issues which originated during transport to the abattoir are referred to the relevant Local Authority.

Some issues may involve both bodies, and APHA carry out an initial triage of all referrals to ensure the correct authorities have the information sent by the Official Veterinary staff. This is a requirement of EU and Domestic regulation, but also supports FSS's overarching strategic aims of "Food is Safe", and "FSS is a Trusted Organisation", because we ensure compliance with animal welfare standards.

FSS Official Veterinarians investigate any instances where animal welfare could or has been compromised, or where there are non-compliances with the legislation. All welfare incidents are scored depending on the impact.

This report is based on data entered by our Official Veterinary staff of non-compliances, and will be published on a quarterly basis.
