Guidance: Completion of Feed Enforcement and Sampling Returns 2014/15

A. Enforcement Data

- 1. Full Time Equivalent figures should be an estimate of the officer time spent on feed law enforcement and can be entered as a proportion. Please exclude time spent on animal health activities. We have split this into primary production and secondary production, where "secondary production" is being used to describe any feed business activities other than primary production.
- 2. A Feed Business Operator (FeBO) should be designated by its primary activity, for example, a livestock farmer mixing rations with complementary feed for their own use (R10) should be classified as a livestock farm.
- Manufacturers does not include farms which mix feed for their own use.
- 4. Food Businesses selling co-products/surplus foods include food manufacturers and supermarkets placing co-products or surplus foods on the market destined for animal feed use.
- 5. Guidance summarising the requirements of EC Regulation 183/2005 on feed hygiene as they apply to food and drink businesses that supply material for animal feed use can be found at: http://www.food.gov.uk/business-industry/farmingfood/animalfeed/animalfeedlegislation/food-and-drink-businesses/
- 6. Distributors/Transporters include hauliers that transport animal feed.
- 7. Retailers include pet food shops. Retailers that break down pet food from bulk into retail packs for direct sale should be recorded under the heading "Retailers" and not "Packer".
- 8. Written warnings include any non-compliances (breaches of legislation) that require rectification as part of inspections and noted in the report of the inspections.

B. Sampling

- 1. Where sampling information for April 2014 to March 2015 is available on the UK Food Surveillance System (UKFSS), please indicate this in the email reply and the form may be left blank.
- 2. Where sampling information is not available via UKFSS, please indicate the total number of samples to which the breakdown of analyses relates using the form provided.

You will note that the numbers of categories of analysis have reduced significantly since last year in response to concerns about the burden of completing the form. Instead, please record the samples against the category of analyte. Examples of analytes are included below.
