Aye Pickled Ltd is recalling Aye Pickled Curried Kraut because it contains mustard which is not mentioned on the label. This means the product is a possible health risk for anyone with an allergy to mustard.

Risk: Mustard

This product contains mustard making it a possible health risk for anyone with an allergy to mustard.

If you have bought the above product and have an allergy to mustard, do not eat it. Instead return it to the store from where it was bought for a full refund.

Action taken by the company:

Aye Pickled Ltd is recalling the above product from customers and has been advised to contact the relevant allergy support organisations, which will tell their members about the recall. The company has also issued a point-of-sale notice to its customers. We are recalling Aye Pickled Curried Kraut due to a known allergy (Mustard) not being present in the list of ingredients included on the product label.

Please note, the mustard is contained within the Curry Powder used in the product which also contains: Coriander, Fenugreek, Turmeric, Garlic, Corn Flour, Chilli, Sunflower Oil, Bay Leaves and Cloves.

What you should do
