

#### About The Scottish Food Crime and Incidents Unit (SFCIU)

The Scottish Food Crime and Incidents Unit (SFCIU) is the investigations and intelligence gathering arm of Food Standards Scotland (FSS). It focuses on tackling food crime and maintaining consumer protection through the management of food incidents.

Food incidents are defined as any event where, based on the information available, there are concerns about actual or suspected threats to the safety, quality or integrity of food / feed or fraud that could require intervention to protect consumers' interests.

All incidents recorded by the SFCIU Incidents Team are reviewed, assessed and classified to determine the appropriate response for the incident. The below table details the levels of response:


Level	Response				
Level 1	A serious situation that requires a formalised and coordinated operational response.				
Level 2	A routine incident that can be managed using standard operating procedures and does not require direct senior leadership involvement.				
Level 3	A severe incident that requires strategic decisions and direction due to adverse scale and severity. A crisis situation due to its abnormality of threat to FSS' reputation or license to operate.				
Level 4	A major incident of such significance that it requires central Government to coordinate the response due to its threat to the public.				




#### **Incidents Recorded**

From April – June 2019 SFCIU Incidents Team recorded 23 incidents.

Of the 23 incidents recorded, 1 was classified as a Level 2 - serious situation. All other incidents were classified as Level 1 - routine incident.




Of the 23 incidents recorded between April and June 2019, the graph below details the incident categories:
