Synopsis

- As of 1st October 2021, food businesses in Scotland are required to include detailed ingredient and allergen information on labels for prepacked for direct sale (PPDS) foods.
- FSS has produced several resources relating to the new labelling legislation
- FSS requests that any queries, feedback and/or further clarification etc. relating to the new labelling legislation are to be emailed to Enforcement@fss.scot so that guidance documents can be updated
- An email will be sent imminently seeking figures for existing food FTE resource at each LA as well as the establishment FTE (revealing any vacancies) and the estimated FTE requirement for meeting all food law-related obligations

- FSS intend to send out a series of surveys (approximately every 3 months) to monitor and track progress on the implementation of the LA recovery plan
- Regardless of whether a spreadsheet is used to run the intervention programme, all completed interventions must be put into the LA MIS so they are visible in SND as FSS need to know what has been completed
- FSS are due to recommence the LA audit programme virtually and intend to carry out three audits before the end of March 2022
- A revised draft of Terms of Reference is available on the SFELC KHub ([link](#)). Committee members are asked to review and to send any comments onto Paul.Bradley@westlothian.gov.uk by 31 October 2021

4.1	Allergens by Grainne Gilson Smith
	Grainne Gilson Smith provided an overview of the new legislation which requires food businesses in Scotland to include detailed ingredient and allergen information on labels for prepacked for direct sale (PPDS) foods which will come into force on the 1st October 2021. The law will make it a mandatory requirement for food

	<p>businesses to include the product name and make sure a full list of ingredients, including allergen information, is clearly identifiable. Prepacked for direct sale refers to any item of food packaged so that its contents cannot be altered before being sold to the customer, such as sandwiches, pies, burgers, ready meals or cakes/baked goods prepared and packaged by a food business before the consumer selects them. The changes also include food items which have been packaged before being offered for sale on the same premises or from a mobile or temporary business, such as a market stall or food truck owned by that same business.</p> <p>To support officers and Food Business with the changes FSS has produced several resources which can be found on the PPDS Hub on the FSS website;</p> <ul style="list-style-type: none"> • Food Allergen Labelling and Information Requirements - Technical Guidance • Guidance on labelling of food sold prepacked for direct sale • A short video to help explain the legislation change • A decision tool to help businesses understand how they will be affected by the requirements • Food prepacked for direct sale Q&A • MenuCal (PPDS Update Implementation coming early Oct 2021) • Example labels • Promotional Toolkit • Food Business Operator Template Letter (Annex) • CookSafe / ButcherSafe / RetailSafe - Updated Allergen Inserts <p><u>Q&A</u></p> <ul style="list-style-type: none"> • Thanks were given to all those who contributed to the workload on allergen labelling as well as to all those who helped produce the guidance documents relating to the new allergen labelling legislation. • Environmental Health Officers (EHOs) will foremost be educating Food Business Operators (FBO) about the new labelling legislation and only when there is strong evidence of non-compliance will enforcement action be considered. • Mass caterers (e.g. restaurants, coffee shops, hotels etc.) are exempt from the Quid percentage of meat declaration • Any queries, feedback and/or request for further clarification etc. are to be emailed to Enforcement@fss.scot so that the guidance documents can be updated
4.2	LA Restart by William Hamilton & Marion McArthur
	<p>Billy Hamilton commenced by briefly updating the Committee on the overall progress by Local Authorities in relation to the recommencement of programmed food law interventions. He advised on the inhibiting factors which currently include continuing Covid demands on LA EH services, physical distancing considerations, self-isolation of officers and higher than normal levels of non-compliance at food businesses. There then followed an update on the FSS Enforcement Branch proposal to seek details of the outcomes of the resource calculation. An email will be sent imminently</p>

	<p>seeking figures for existing food FTE resource at each LA as well as the establishment FTE (revealing any vacancies) and the estimated FTE requirement for meeting all food law-related obligations. The information collated from this exercise will be shared with Scottish Government, SOLACE and the Society of Chief Officers of Environmental Health in Scotland.</p> <p>Billy then set out the ongoing issues relating to LA restart including development of the resource calculation methodology, resolution of MIS-related problems, service planning by LAs and ongoing monitoring of LA progress by FSS</p> <p>Marion thanked all LAs for returning the LA readiness and resilience survey which provided a baseline of where LAs currently are. She went on to explain that FSS intend to send out a series of surveys during implementation of the LA recovery plan to monitor and track progress and that it was likely that these would be issued every three months.</p> <p>Marion made the point that all completed interventions must be put into the LA MIS so they are visible in SND. Regardless of whether a spreadsheet is used to run the intervention programme FSS need to know what has been completed. This information is needed for on-going monitoring and for the MANCP at the end of the year</p> <p>Lastly Marion advised that FSS are due to recommence the LA audit programme and intend to carry out three audits before the end of March 2022</p> <p><u>Q&A</u></p> <ul style="list-style-type: none"> Audits will continue to be done remotely
