5.1	FSS Board Member – Kate Richards
	Kate Richards (FSS Board Member) expressed her thanks to the Committee for the invitation to outline her background and roles with FSS. Kate highlighted that she graduated in Edinburgh as a vet and is a member of the Royal College of Veterinary Surgeons (MRCVS), who regulate vets and vet nurses in the UK. Kate's current roles, background and experience with Food Standards Scotland can be found in the presentation link below.
	Question, Answers & Observations
	The Chair highlighted the shortage of vets in the UK and emphasised how Environmental Health are facing similar issues, and asked Kate if there are any actions or initiatives that the Royal College have introduced to promote the profession and recruit more vets that could also help Local Authorities. Kate outlined that 25% of new registrants every year were from non-UK vet schools, however this number plummeted after Brexit in terms of non-UK EU vets coming over for work. Lots of work has been done to promote working in public health in the country, ensuring undergraduates and vet schools know what working in public health is about and how important the role is. There is work ongoing where the RCVS are working with vet schools in the

EU to directly accredit them, meaning when students graduate, the RCVS automatically recognises their degree so they can come to work in the UK.

5.2 **REHIS Presentation**

Sandra Williamson introduced herself to the Committee as the Director of Training at REHIS. Sandra outlined that REHIS are an independent self-financing registered Scottish charity who don't receive Scottish Government or NHS funding; finances come through membership and courses, and fees received for professional qualifications or for Approved Training Centres. The main objectives of REHIS are for the benefit of the community to promote the advancement of Environmental Health. Sandra provided a presentation covering: an overview of REHIS, community training, REHIS courses / qualifications, and credit rating / level of courses.

Question, Answers & Observations

- Scott Anderson at Scottish Bakers raised that as part of Scottish Bakers mission, they are similarly trying to propose schools' programmes to highlight food and drink into schools as part of the educational curriculum to promote profession in the food and drink sector. Sandra highlighted she also works on food education partners with Food and Drink Federation Scotland, who have been promoting STEM ambassadors to promote different professions. Scott and Sandra will meet to discuss schools' programmes in relation to education on food safety.
- Rachel Mirfattahi highlighted that SmartSTEMs (a charity who work with schools in Scotland) are working on holding a food and drink event next year to promote the sector to schools. Details on this will be circulated round the Committee.
- The Chair noted that East Renfrewshire have been working on 'Developing the Young Workforce' representatives and are attending careers fairs to promote Environmental Health. The Chair recommended that representatives within Local Authorities seek out the 'Developing the Young Workforce' to open doors into the profession. The Chair is going to provide information to Andrea Carson / Hazel Stevenson to ask the Society of Chief Officers about EH ambassadors becoming STEM ambassadors.

7 The SFELC Executive update

- Food Standards Scotland Science team provided a presentation on LA food sampling in Scotland in 2023-24. Sample numbers are continuing to increase post-pandemic. Discussions were had on the 'UKHSA guidelines for assessing the microbiological safety of ready-to-eat foods placed on the market' and it was agreed the guidance is applicable in Scotland and will be used in place of the former health protection agency guidelines.
- The Scottish Food Law Intervention manual has been finalised and is now a live document for enforcement officers. The Executive recorded their thanks to

- Luke Henderson and the Interventions Working Group for their work in producing the manual.
- Sheena from REHIS gave an update on the professional exams and student numbers, advising that the University of the West of Scotland BSc course in Environmental Health is currently closed to new entrants but will support second, third, and fourth year students through to completion. The first student to progress through the alternative pathway to Environmental Health has passed. If anyone would like further information on the alternative pathway then this can be found on the REHIS website.

9 & 10 | Food Standards Scotland Update / SAFER Update

- FSS have had several visits including Canadian authorities who were over for an audit of cutting plants, cold stores and abattoirs. FSS have also recently finished a dairy audit from Sante F, Lorna Murray thanked the Local Authorities and officers involved in this. FSS have a heavy audit schedule that Sante F are intending for 2025, and the first will be on live bivalve molluscs around February-March.
- There is a paper going to the December Executive Management Board (EMT)
 on the Food Law Rating System to discuss ways forward, considering
 alternate ratings within bandings with the intention for this to be an interim
 measure before being considered against ambitions for SAFER. This was the
 recommendation from the FLRS report.
- FSS are looking at the 'Fife Pilot' and are taking a paper to the EMT meeting in December to advise other managers within the organisation of this pilot.
- There is work being carried out on cultivated protein where there will be a 2year trial taking place. FSS have partnered with FSA on this to consider safety and labelling considerations, consumer appetite, and potential legal change necessary. FSS Policy colleagues are leading on this.
- Discussions have been ongoing on research programme activity for 2025-26, FSS have proposed social research in relation to business compliance.
- 3 HACCP courses are currently being run. Around 51 officers expressed interest but only 35 can be accommodated this year. Internal discussions have been ongoing on future training possibilities for LA officers and how best to make this as accessible as possible.
- Work is ongoing in relation to SAFER and the CivTech programme, which allows for digital developments and innovation within governance framework.
 There will be an 18-week piece of work in terms of discovery phase and

	research phase. It is likely that during this, LAs and industry will be contacted to gather their views as part of the research. • All LA members should now have the Resource Calculator. • FSS Comms team are looking for people to user test the website, details of this are in the Monthly Enforcement Report.
