SFELC Objectives

The Scottish Food Enforcement Liaison Committee will work to support and influence the policies of the Food Standards Agency in Scotland, in order to improve the effectiveness and consistency of food law enforcement in Scotland. In doing so the Committee will proactively seek to influence the development of Agency policies which affect enforcement issues by providing advice based on its collective opinion.

The Committee will co-ordinate food safety activity by local authorities and promote best practice in food safety service delivery. In doing so, the Committee will establish working groups as necessary to identify best practice and effective service delivery models.

SFELC Remit

The Committee shall;

- Meet on a regular basis. The Committee shall ordinarily meet four times per annum.
- Contribute to the development of the Food Standards Agency strategies in Scotland to improve their effectiveness.
- Promote the consistency of Food Law Enforcement in Scotland.
- Assist in the establishment and maintenance of an effective enforcement infrastructure.
- Consider and propose new enforcement mechanisms and approaches and produce recommendations for their implementation.
- Consider any other issues relevant to the working relationship between the Food Standards Agency, Food Law Enforcement the food industry and consumers in Scotland.
- Comment on relevant draft legislation, guidance and reports produced by the Food Standards Agency and other relevant agencies.
- Support and direct the work of the Subcommittees, working groups and any other bodies set up under the auspices of the Scottish Food Enforcement Liaison Committee.

Resources Working Group

During the year the Committee approved the Training Guidance document for circulation to Local Authorities. It is intended that this be a live working document which will be revised as and when required.

The Group devoted a significant amount of consideration to one of the most important issues to impact on food safety for a long time, namely the proposed New Food Body (NFB). This work led to SFELC submitting detailed comments and suggestions to Scottish Ministers to facilitate the formulation of the consultation document.

A survey carried out in relation to export certificate activity by the Food Standards Subcommittee found a wide variation in relation to fees, charges, food types covered, certificates issued, and wording on certificates. SFELC agreed to this being considered further by the Food Liaison Groups with possible feedback through the NFB consultation.

Following on from the response to the NFB consultation and confirmation that the Scottish Government planned to move ahead with the creation of the NFB, it was agreed that it would be appropriate to develop a Framework Agreement i.e. an agreement between Scottish LA's and FSA which covers all areas of the food service delivery (this is currently in place nationally) in Scotland. RWG have started work on a document suitable for Scotland with the aim of having this ready for the commencement of the NFB. The work on this document has started but, due to the magnitude of the task, will not be completed until programme year 2013-14.

Standing Subcommittees / Ad Hoc committees

In order that the strategic objectives of the Scottish Food Enforcement Liaison Committee can be implemented, standing and ad hoc subcommittees provide a supporting structure for SFELC.

Core standing subcommittees dealing with Food Safety, Food Standards and Feeding Stuffs are augmented by ad hoc subcommittees and short-life working groups established by SFELC or its subcommittees as and when required. These groups report back to SFELC.

The Chairperson of Food Safety and Food Standards subcommittees will normally be nominated by SFELC, however if this is not possible a member of SFELC will fulfil the role of chairperson. The Feeding Stuffs subcommittee Chairperson is nominated by Society of Chief Officers of Trading Standards in Scotland (SCOTSS).

The standing subcommittees will be delegated to act on behalf of the Committee in respect of those matters remitted for their attention and/or action. The Chairperson of each subcommittee will liaise directly with the Chairperson and Secretariat in respect of those items which require the consideration of the Committee to ensure that appropriate recommendations / reports are brought before the full Committee for ratification and further action. Several SFELC Working Groups report to each of the subcommittees and are considered to be an important avenue for the enforcement community to influence food safety practice in Scotland.

Remit

The Subcommittees will be responsible for delivering the main Committees strategic aims by considering and recommending appropriate measures for the practical implementation of any initiatives remitted to them.

The Subcommittees shall

- Meet as directed to discuss issues referred to them by SFELC and to report back. In particular they should provide expert advice and guidance on issues of strategic importance in the field of enforcement and likely impact of any of SFELC's recommendations.
- Hold meetings at least two weeks before the main meetings so that decisions can be reported back.

Food Safety Subcommittee

The Subcommittee met four times during 2012-2013. Key topics discussed and progressed were as follows:

Engagement with FSA Operations

The Subcommittee had long felt that engagement with FSA Operations would greatly assist long-term liaison between Local Authority and FSA enforcement agencies. FSA operations have, consequently been attending the Subcommittee meetings since November 2012.

Better Regulation

The Chair of SFELC and the Chair of the Subcommittee met with representatives of the Scottish Government to progress matters relating to aspects of the Regulatory Reform (Scotland) Bill. The said Bill seeks to amend the Civic Government (Scotland) Act 1982 in order that Certificates of Compliances issued to mobile food vendors may be transferable between Scottish Food Authorities. It was agreed that the Subcommittee would draft a National Standard for Mobile Food Vendors. This document will establish a food hygiene compliance standard upon which Certificates of Compliance may be issued in future. The proposed deadline for completion of this task is December 2013.

Waste (Scotland) Regulations 2012

The Chair of the Subcommittee (and the Chair of the Food Standards Subcommittee) met with SEPA and Zero Waste Scotland in order to discuss the implications of the Waste (Scotland) Regulations 2012 and their possible impact upon food safety in

certain food outlets in future. There is a programme of training planned for Local Authorities, delivered by Zero Waste Scotland

FSA Cross Contamination Guidance

The implementation of the FSA Guidance continued during the year with regular discussions at subcommittee meetings including feedback on initiatives pursued at the Food Liaison Groups. It was agreed that a survey of all Scottish Local Authorities should be conducted in order to obtain a clear picture of the approach being taken by Authorities and to seek opinion upon training needs.

Remedial Action Notices

The survey conducted into Cross Contamination Guidance implementation amongst Local Authorities also included a section on the extension of powers to serve Remedial Action Notices to all food businesses. Feedback revealed that while use of the extended powers was not yet widespread, almost all respondents expressed positive views on the addition to officers' enforcement toolkit.

Fish and Shell Fish Working Group (Scotland & Northern Ireland)

The Group's current remit is to promote consistency by co-ordinating strategy for the enforcement of food safety legislation in the seafood sector. The group maintains a communication network between member authorities, the FSA, trade associations and other enforcement agencies on fish and shellfish matters.

During 2012/2013 work included the following:-

- 1. Involvement in the development of a common format for export certification of fishery products to China.
- 2. Publication of an advisory leaflet on food safety relating to oysters for processors, caterers and retailers.
- 3. Co-ordination of approach in relation to illegal shellfish harvesting.
- 4. Procedures and charging systems for issuing Export Health Certificates.
- 5. Ongoing implementation of shellfish official controls.

Two sampling surveys proposed for the year namely scallop meat shelf life and sulphur dioxide in water in prawns were carried over to 2013/14

HACCP Working Group

This working group, having completed amendments to CookSafe in cognisance of the FSA's Cross Contamination Guidance, re-formed to draft a HACCP-based guidance manual specifically for butchers. The group has worked hard to ensure that the document is carefully researched and that the text is tested with butchers as it evolves. The Scottish Federation of Meat Traders Associations (SFMTA) provided valuable contribution to the development of the text at a meeting held at their offices in Perth on 05/10/12 and then again when the text went out for stakeholder comment from December 2012 – January 2013.

The working group met 11 times prior to issuing a draft to stakeholders for comment in December 2012. A further 2 meetings were held during 2012-2013.

The document, which will be titled "ButcherSafe" is now reaching an advanced drafting stage and is expected to be completed September 2013¹.

Food Hygiene Information Scheme Implementation Group (FHIS)

There were 4 FHIS Implementation Group meetings during 2012-2013.

In addition, 3 meetings of the FHIS Lead Officers' Working Group meetings took place during the year, chaired by the Subcommittee Chair.

A further three local authorities have launched FHIS during 2012 – Comhairle nan Eilean Siar, Highland Council and Shetland Islands Council.

2013 has seen East Ayrshire Council, North Ayrshire Council and Falkirk Council launch FHIS so far. East Dunbartonshire Council, Orkney Islands Council, West Lothian and North Lanarkshire Council plan to launch by the calendar year end. The remaining two local authorities - South Lanarkshire Council and Dumfries and Galloway Council both plan to launch by the end of the financial year 2013-2014.

The first Scotland-wide promotional campaign was rolled-out this year with National Headlines including:

- 90 adverts and advertorials across:
 - 5 national papers Daily Record, Sunday Mail, Scotsman, Herald & Metro
 - 28 regional newspapers
 - 2 BBC magazine titles (Good Food and Olive)
 - 28 regional newspapers
- FHIS Facebook page launched Facebook.com/FoodHygieneInformationScheme

Approved Establishments Working Group

The Group continued working upon a document aimed at providing an inspection protocol in approved establishments. Unfortunately, competing demands faced by Group members prevented completion of the document during 2012-2013. However, recent progress suggests that the guidance should be completed during 2013. It is anticipated that the said document may be suited to an associated training package.

Childminders Working Group

The Childminders Working Group reviewed the system to deal with food business registration of Childminders in Scotland. The Care Inspectorate Registration pack contains a Food Business Registration form for new Childminders to complete and send to their Local Authority directly. For existing Childminders, Local Authorities carried out desktop reviews to establish if they also needed to register. The working group were mindful of 'The Red Tape Challenge' taking place in England and SFELC will review the Scottish position again following any impact on Childminders.

Food Standards Subcommittee

The main work of the Subcommittee during the year revolved around the proposals for implementation of the EU Food Information for Consumers Regulations (FIR) and the SFELC survey programme.

The Subcommittee recognises that FIR will have a significant impact on food standards in Scotland and sought to engage actively with consultations on the Scottish enabling Regulations and guidance. As well as a number of meetings with FSA staff the Subcommittee developed a response to the official consultation which was also used by FLGs and individual local authorities to form their own responses. FSSC remains committed to working with FSA and other stakeholders to ensure the effective and efficient implementation of FIR.

During the year the following survey reports were approved:

- SF26 Microbiological quality of prepacked sandwiches at end of shelf-life
- SF27 Colours in confectionery, with a particular focus on imported food
- SF28 Accuracy of labelling of food aimed at gluten intolerance sufferers
- SF29 Microbiological quality of potted meat and similar products
- SF30 Accuracy of meat species labelling and use of food colours in Indian, and similar, catering premises

The Subcommittee's Research Working Group (RWG) continued to use the information recorded by Scottish LAs on the UK Food Surveillance System to advise on sampling and enforcement priorities.

During the year FSSC discussed a diverse range of composition and labelling issues brought forward by food liaison groups, laboratories and the FSA.

Feedingstuffs Subcommittee

The Feeding Stuffs subcommittee had three business meetings during 2012-13 which addressed a broad range of issues, including;

- Review of Official controls for Feed
- New Food Body consultation
- Entry Powers for Feed Officers at Ports and other Feed Businesses
- Local Authority Audits
- Supermarket waste
- Training Needs and Opportunities

The SFELC Feed subgroup acts as a conduit for the Regional Quality groups and discusses emerging issues from feed officers. We work in partnership with the Animal Medicines Inspectorate (AMI) on joint enforcement issues.

A Scottish Feed officer now sits on the National Animal Feed Ports Panel (NAFPP) which comprises representatives of UK enforcement bodies and government departments with an interest in imported animal feed controls and has similar terms of reference to the feedingstuffs subcommittee itself.




SFELC group structure

Co-ordinating and governance structure


